## Affordable Health Coverage for Hoosiers in Agriculture Coming Soon

For several years, [Indiana Farm Bureau](#) (INFB) has heard from its members that rising health care costs are impacting the financial stability of the family farm. Due to the rising costs and lack of affordable options, INFB will soon be offering its members access to more

INFB Health Plans will benefit members in all 92 counties who do not have access to group insurance plans or who work somewhere primarily for health benefits. This includes farm owners, those who work on farms, agribusiness professionals and rural entrepreneurs with fewer than two employees or who do not qualify for significant Affordable Care Act subsidies.

**INFB will open applications for its health care plans on October 1, with health benefits to take effect January 1, 2021.**
